### CARA STATEWIDE LOBBY DAY - A HUGE SUCCESS

### YES on SB 562 and AB 796!

Thanks to the 200+ CARA and CICA members who participated in the lobby day on May 25<sup>th</sup>. We had a great day (even with a few logistical glitches). The weather was great, spirits were high, the dancing fabulous, and we really took over the Capitol. 32 lobby teams, led by fabulous CARA/CICA leaders, successfully visited over 112 offices (a few offices were locked) and talked with each office about SB 562 (Healthy CA Act) and AB 796 (increasing SSI). Our FLASH MOB made it on two 6pm Sacramento news stations, and while we were there, SB 562 passed out of Senate Appropriations! Not bad for a days work, right?

Many thanks to our partners who helped prepare us for our visits – Michael Lighty from CNA, Jared McCleary from CA Partnership, and Mike Herald from the Western Center. A shout out goes to Assemblymember David Chiu (SF) who welcomed us and arranged for the permits so we could have our rally at the Capitol. Days like May 25th really prove why CARA Rocks. But we must keep the pressure on these bills - and our eyes on the budget negotiations happening this week. Our work is not over.
