# About Betty T. Yee Candidate for Governor

Betty Yee is the former California State Controller. She was elected in November 2014, following two terms of service on the California Board of Equalization, the nation's only elected tax commission. Re-elected in 2018 for a second term as Controller earning the



highest number of votes of any candidate nationwide that year --- over 8 million votes --- Betty was the 10th woman elected to statewide office in California's history.

As Chief Fiscal Officer of the world's then-fifth largest economy, Betty, among other responsibilities, served as a member of the California Public Employees' Retirement System (CalPERS) and the California State Teachers' Retirement System (CalSTRS) boards, whose combined portfolio reached \$800 billion. She led the work at both pension funds that culminated in the funds' net zero pledges.

Betty served on dozens of boards, commissions, and financing authorities affecting policies ranging from land management, affordable housing, and alternative transportation to crime victim compensation and health and educational facilities.

As Chair of the State Lands Commission, she provided stewardship of public-trust lands, waterways, and marine resources through economic development, protection, preservation, and restoration consistent with the state's environmental needs. In this capacity, she spearheaded, among other things, the shuttering of the last state oil platform on the Santa Barbara channel. As a member of several housing financing entities, Betty sponsored legislation to streamline the state's housing finance programs and called for stricter accountability over state funds directed towards addressing homelessness. Over her eight years as Controller, she and her audit team uncovered \$7.5 billion in unallowed spending.

With close to four decades of experience in public service specializing in state and local finance and tax policy, Betty earned a BA in sociology from the University of California, Berkeley, and a MPA from Golden Gate University in San Francisco. She currently serves on the Board of Directors of Ceres, a national sustainability organization, and the Asian Pacific American Institute for Congressional Studies.

After her service as State Controller, Betty served as a Fellow with the University of Southern California Dornsife Center for the Political Future where she led a discussion and study group on the relationship of good governance and the health of our democracy. Betty is a declared candidate for Governor.

#### Call to Order

President Tsutsui called the meeting to order at 6:31 p.m.

#### Review and Approve the August 2025 Meeting Agenda

On the motion of Bashor and a second by Akacic the agenda was unanimously approved with no nays nor abstentions.

## Review and Approve the July 2025 Membership Meeting Minutes

On the motion of Tsutsui and a second by Bashor the agenda was unanimously approved with no nays but one abstention.

## Officer Reports:

President (Neil Tsutsui)

- **ECDC Annual Dinner** October 25, 6:00-9:00 pm. at Arlington Community Church. Speaker BettyYee. We will provide food, please bring drinks to share. There will be a silent auction and opportunities for sponsorship. If you have anything for the silent auction, please contact the E-Board. \$60 per person \$75 after September 20, 2025
- Prop 50, "Election Rigging Response Act," was approved by the legislature and Governor. There will be an election on November 4th to ask the voters to redistrict. This is a response to Trump asking Texas to redistrict to change five seats to Republican in the House and secure the House for Republicans in the 2026 midterm elections. This is an all-hands-on-deck moment to precinct walk and drop literature. At next month's meeting, there will be a presentation on the '26 midterms including Prop 50.

## Democratic Party of Contra Costa County (DPCCC) Report (Champagne Brown)

 Prop 50. Several redistricting commissioners are in favor of redistricting. Subtle changes are being made. California is following the redistricting commission's recommendations and is bringing the proposition to the people unlike Texas. Solano County losing Antioch, Desaulier getting the most of Contra Costa County. Josh Harder will get Antioch and Pittsburg, making that seat more reliably Democratic.

## WHERE WILL THE LIBRARY BE LOCATED?

- The Committee for a Plaza Station Library <u>recommends</u> the ground floor of the BART TOD building to be built at the southwest corner of the BART Plaza Parking Lots at the corner of Fairmount and Liberty Streets.
- BART and the City have agreed to a lease of \$1.00 per year for 99 years.
- This location is convenient to BART, to the Ohlone Greenway, for walking, for bicycling and the city will ensure that there is short-term parking as well as parking for people with special needs
- This location is convenient to schools such as El Cerrito High School, Harding Elementary, Fairmount Elementary, Korematsu Middle School, Prospect Sierra School and more.

## WHEN BUILT DETERMINES COST

- BART's Transit Oriented Development moving forward groundbreaking for Building A this year, 2025
- Library in Phase Three scheduled groundbreaking in 2027
- Any other alternative would need a location and would be built in 2030, or later, at a much greater cost!

## HOW CAN WE PAY FOR THE NEW LIBRARY?

- Borrow the money to design and build the library
- · Create new revenue stream to pay for the debt
- Limit the new revenue to pay only for library expenses
- Have the revenue make the library costs independent of City's existing budget
- Create a new tax to cover the construction debt and initial operating costs above
   County minimum operations

## HOW WILL NEW TAX BE IMPLEMENTED?

- New Ordinance proposing up to \$0.17 per square foot of improved building area for up to 30 years after first bond issued
- City Council to adjust rate to be <u>only</u> what needed for Library Construction Debt and first 10-years of Library operations
- If Construction is delayed, City Council can adjust the maximum rate to maintain purchasing power
- · Low Income Senior Exemption permitted
- Registered Voters petition the the City Council to place this New Ordinance on ballot

## **HOW MUCH WILL A PROPERTY OWNER PAY?**

## **OPTIONS FOR LOWER TAX**

- 1) Once the Special Library Tax is approved, the City will be able to apply for grants from private and public sources. Any funds granted can be applied to reducing the debt and therefore allow for a lower tax rate.
- 2) Senior Citizens who are eligible may have their taxes reduced or held back until their home is sold.

## **HOW DOES PETITION WORK?**

- A petition signed by 10% of the registered voters is the "will of the people"
- Ten percent of the registered voters is 1,800 signatures
- City Council must put on a future general election, and may put on a special election
- Courts determined that ballot measures placed on the ballot by the "will of the people" only need simple majority
- Earliest possible election likely June 2, 2026

## WHY SIGN THE PETITION

- Signing the petition only places the funding measure on the ballot it does not enact the new Ordinance
- Any new library alternative needs funding and this new Ordinance is not specific to a Plaza Station Library
- The Plaza Station Library is the fastest and cheapest solution for a 20,000 square foot library - schedule and cost certainty
- The Plaza Station Library option expires in 2026 signing the petition means this inexpensive solution remains viable

# 5. Program: Neil Tsutsui, "The Election Rigging Response Act (Prop 50) and Prospects for the 2026 Midterm Elections"

Neil Tsutsui is a Professor of
Environmental Science, Policy, and
Management at UC Berkeley and current
President of the El Cerrito Democratic
Club. Neil has served on a variety of local
and regional committees, including as
Chair of the El Cerrito Environmental
Quality Committee, Chair of the Parks
Advisory Committee for the East Bay
Regional Parks District, and
Vice-president of the West Contra Costa
Sierra Club.



Neil was originally planning to present on the outlook for the 2026 mid-term elections, but now that Prop 50 will be on the ballot, he will also give an overview of the redistricting changes and what they mean for Democrats in El Cerrito and the larger Bay Area.

Neil has also launched a super-PAC, called "*Flip 1 Seat*" (<a href="www.flip1seat.org">www.flip1seat.org</a>) to do targeted fundraising for flipping a single, currently Republican House seat in California.




## 6. Reiterating: What Does Redistricting Mean?





Winning back the House of Representatives starts now!

As you have probably seen, there was lots of action these last weeks on California redistricting. Two momentous events in particular - the state Assembly and Senate passed the "Election Rigging Response Act" (Prop 50) and the California Supreme Court rejected a Republican challenge to redistricting.

Overall, the goal of this effort is to offset the mid-decade redistricting that Trump demanded in Texas to gain 5 Republican seats in the House. It is anticipated that the California redistricting would add an additional 5 Democratic seats, plus secure some wobbly blue seats.

The California special election will be on Nov 4, and ballots will drop Oct 6. It will be a short, intense sprint from now until then.

The California Democratic Party (CADEM) will be providing literature and access to PDI for local groups - I have requested 4000 walk pieces for El Cerrito.

Things are moving quickly, and I will try to keep you updated as I find out more, but here are some resources if you're interested in learning more.


## 9. Call for Newsletter Submissions
