### 2. September General Meeting Preview – Poor People's Campaign

For our September meeting, the ECDC will host a presentation from The Poor People's Campaign. In 1968, Rev. Dr. Martin Luther King Jr. and many others called for a "revolution of values" in America. They sought to build a broad, fusion movement that could unite poor and impacted communities across the country. Their name was a direct cry from the underside of history: The Poor People's Campaign.

Today, the "Poor People's Campaign: A National Call for Moral Revival" has picked up this unfinished work. From Alaska to Arkansas, the Bronx to the border, people are coming

together to confront the interlocking evils of systemic racism, poverty, ecological devastation, militarism and the war economy, and the distorted moral narrative of religious nationalism. We understand that as a nation we are at a critical juncture — that we need a movement that will shift the moral narrative, impact policies and elections at every level of government, and build lasting power for poor and impacted people.

ECDC will host a conversation with local members of the campaign to explain their principles and priorities. They will also share what residents can do to further their mission and goals.

### California State Attorney General Rob Bonta – Keynote Speaker



Rob Bonta grew up the son of activists. His mother, Cynthia, a proud Filipina, immigrated to California in the 1960s by a three-week boat ride. His father, Warren, who grew up in Ventura County, was committed to service and social justice from a young age. As a student, Warren joined Martin Luther King's civil rights organizing in Alabama to pass the Voting Rights Act. Warren and Cynthia were working as missionaries in the Philippines when Rob was born, training young people to serve the needs of rural Philippine villages through service, community organizing and ministry.

After leaving the Philippines, the Bonta family moved to the Los Angeles area where his parents worked for the United Farm Workers gathering signatures outside of supermarkets in support of the lettuce boycott. Shortly thereafter, they moved to a trailer in La Paz, in the Tehachapi Mountains outside Bakersfield that served as the headquarters for the United Farm Workers movement. Rob's parents worked alongside Cesar Chavez, Dolores Huerta, and Philip Vera Cruz, organizing Latino and Filipino farmworkers for racial, economic, and civil rights. His dad worked in the front office and helped set up health clinics for the farmworkers, while his mother worked at the daycare, Casa de Nana, to support farmworker organizer families. Rob's padrino, or godfather, Jose Gomez, was the Executive Assistant to Cesar Chavez.

Growing up, Rob had been inspired by characters like Atticus Finch in "To Kill A Mockingbird" to pursue justice through the law. Throughout college and in his community work, he saw injustice and the power to right wrongs through the law, and after college, he was accepted to Yale Law School. There, he debated the law and current events with classmates and friends like Cory Booker, Gina Raimondo, and Stacey Abrams. After law school, Rob served nine years as a Deputy City Attorney in the San Francisco City Attorney's Office.

Now, as California's State Attorney General and chief law officer, Rob strives to be the "attorney for the people," winning justice for California families and holding accountable those who break the law – especially those in positions of power. He knows that enforcing the law and public service is about helping people, making people's lives better, and improving the human condition.

# 6. Special Thanks to All Who Worked to Defeat the Recall of Governor Newsom

As we all know by now, the largely-Republican led and hugely expensive effort to recall Democratic Governor Gavin Newsom was soundly defeated on September 14<sup>th</sup>. Many among us worked diligently to defeat the recall – going door-to-door talking to our neighbors, passing out flyers, putting up yard signs, canvassing at farmers markets and BART stations, calling voters, etc. Although the results will not be certified by the California Secretary of State until mid-October, current tallies have 71.5% voting "No" to the recall, significantly higher than the 61.9% of votes Governor Newsom received when he was elected in 2018. While recall proponents and the Republican Party hoped to capitalize on low voter turnout that's typically associated with a special election, turnout was surprisingly high, with 64.2% of registered voters voting, just slightly less than the 64.5% who voted in the 2018 general election.

The ECDC extends a huge "Thank You!" to all of those who volunteered their time and made contributions in support of Governor Newsom and the democratic process.

### 10. Rental Assistance Information from State Senator Nancy Skinner

#### State of California COVID-19 Rent Relief Program:

#### Now Covering 100% of Rent & Utilities for Income-Eligible Renters and Landlords

The State of California has increased funding for income-eligible renters and their landlords who have been impacted by COVID-19 to cover 100% of unpaid and future rent or utilities. This increase in rental assistance payments to 100% of unpaid rent will help make landlords whole and keep tenants housed.

You can verify your eligibility for the CA COVID-19 Rent Relief program and apply immediately by visiting <u>HousingIsKey.com</u>, or by calling 833.430.2122. Additionally, if you are an applicant who has already received funding through the program, you will be compensated the difference to receive 100% coverage – there is no need to re-apply!

# California's critical eviction protections have also been extended for renters impacted by COVID-19, through September 30, 2021, to help keep vulnerable families housed.

### Who Can Apply?

• **Renters:** If you are an income-eligible renter, you can apply on your own and receive financial assistance for unpaid rent, dating back to April 1, 2020, or help with future payments, even if your landlord doesn't participate.

If you are an income-eligible renter whose landlord does participate in the program, you will need to complete the joint application. Once your landlord applies, you will be notified to submit information to complete the application process.

• Landlords: If you are a landlord and participate in the COVID-19 Rent Relief program, you can get reimbursed directly for 100% of your eligible renters' unpaid rent, dating back to April 1, 2020.

#### What Help Can You Get?

• Assistance is available for 100% of unpaid rent and utilities, dating back to April 1, 2020, as well as future rent and utility payments. Utility payments will be paid directly to utility providers at 100% of cost but are limited to a total of 12 months.

#### What Else Should You Know?

• The application process has been significantly simplified. It now takes less time to complete, requires less paperwork to be uploaded, and offers helpful tips throughout the application.

Assistance from the CA COVID-19 Rent Relief program does NOT count as earned income for renters and will NOT affect eligibility for any other California state benefit assistance programs, such as CalFresh and CalWORKS. All applicant information is kept private and will not be shared. Income-eligible applicants may qualify regardless of immigration status and will not be required to show proof of citizenship.

#### How to Apply:

• To check eligibility and apply, visit <u>HousingIsKey.com</u> or call 833.430.2122. Once your application has been processed, you will be notified about your application status and next steps.

If you need assistance in another language or need help checking eligibility, filling out your application or uploading paperwork, schedule an appointment with a local organization near you by calling 833.687.0967.
