3. Minutes from the February 27th General Membership Meeting

El Cerrito Democratic Club General Membership Meeting Minutes February 27, 2024

(in person at Hana Gardens, 10860 San Pablo Ave, El Cerrito; and via Zoom)

Call to Order

President Brown called the meeting to order at 6:30 p.m.

Approve of February 2024 Agenda

On the motion of Crowley and the second of Smith, the agenda was approved as presented with two corrections to the month (February) changed with no nays nor abstentions.

Approve of Minutes: January 2024 General Membership Meeting

On the motion of Akacic and the second of Crowley, the minutes were approved as presented with no nays nor abstentions.

Officer Reports:

- Membership (Neil Tsutsui) membership = 93 members.
- Finance (Ed Crowley) = Balance \$8774.66. A few memberships came in. There were no outgoing transactions.
- Website (Madeline Kronenberg) Website up to Date.
- Publications (William Ktsanes) two article ideas submitted. Please submit articles if you have them to William.
- Records (Lesie Reckler) No report.

Democratic Party of Contra Costa County (DPCCC) Report

- Kristin Connelly Clerk/Recorder came in and did a great report on the election. Perhaps she should come to talk to the club about elections in Contra Costa County.
- Reach out to people and tell them to return the Ballots. Contra Costa County on par with the state (8% of ballots being returned) mailed 700,000+ ballots. Only 59,996 ballots returned. Terrible turnout so far.
- DPCCC passed a resolution honoring Irma Anderson, Former Mayor of Richmond. First Black woman to be Richmond's mayor and first woman to be mayor of a major city.

- Celebration of Life for Irma Anderson February 29, 2024, 4:00 7:00 p.m. Richmond Auditorium, Public Ceremony. In the future, there will be a documentary made and a Quilting Project honoring Mayor Anderson.
- Nye District 1 Report. Working on DEI matters on the central committee.
 Again echoes the importance of getting out the vote. This is how Democrats lose races and Republicans win.

4. March Program: California Senate District "7" Endorsement Forum

For this month's General Membership Meeting program, the El Cerrito Democratic Club will revisit the possibility of endorsing one of the two California Senate District "7" candidates advancing from the March 5th Primary to the November 5th General Election – **Jesse Arreguín** and **Jovanka Beckles**. Both candidates have been invited to address our March 26th membership meeting (or, if unable to attend, send a proxy).

Below are candidate statements submitted by Jesse Arreguín and Jovanka Beckles.

Jesse Arreguín (Mayor, City of Berkeley)

The East Bay needs a proven, progressive, problem-solver in the State Senate who will fight for more housing, safe neighborhoods, universal healthcare, and better schools.

The son of farmworkers, I was able to overcome the odds and achieve the California Dream, inspiring me to open the doors for others. As a council member and Mayor, I've fought for affordable housing, reducing homelessness, community safety, combating hate crimes, and raising the minimum wage.



We've invested in violence prevention to address root causes of crime, banned ghost guns, increased police oversight, and passed historic reforms to shift responses to mental health calls from police to trained social workers.

We've addressed homelessness in Berkeley through bold, effective action—launching new mental health and addiction services, shelters, and permanent housing.

I'm leading on housing affordability—building more housing than we've seen in decades, protecting renters, and developing a regional plan to build 440,000 new homes.

As your Senator, I'll make the East Bay the best place to live, work, and raise a family, by addressing public safety comprehensively, hiring more officers who live in the communities they serve, building housing at all income levels, addressing homelessness through mental health and housing, improving public education, championing equal pay and the right to choose for women, and combating climate change.

Jovanka Beckles (AC Transit Director, Ward 1)

I'm a former 2-term Richmond City
Councilmember; current AC Transit Director; Black
Latina gay immigrant from Panama. I'm a
community and labor activist; a rank and file
Teamster working as a mental health professional
for over 34 years. Because I live at the intersection
of so many marginalized communities, I'm the best
candidate to represent the East Bay.
Representation matters. The East Bay has not had a
Black woman - any person of color for that matter representing us in the Senate in almost 30 years.
Currently, of the 40 State Senators, only one's
Black. Those who believe in justice & equity should
do everything we can to remedy this injustice.



The many policies that I wrote and passed, are based on my lived and work experience and have received national attention for their boldness, and life-changing impacts. These include: banning the box for formerly incarcerated individuals; wrote and passed the first rent control policy in California in 30 years; raised the minimum wage for Richmond workers, taxed, sued and beat Chevron; significantly reduced crime in Richmond; provided appreciation pay to transit workers. I'm the only corporate-free candidate in the race and the only regionally elected official.

Voters are excited to see a candidate like me - a working class person who looks like them. This excitement will bring them out to vote! Our democracy, our freedom and civil rights are under attack. We win when we come together. I bring our communities together as demonstrated by the many grassroots organizations and local leaders that have endorsed me. 5. ECDC Endorsement Online Voting Instructions - State Senate District "7"

While ECDC General Members Meetings are open to all, only ECDC Members in Good Standing as of Saturday, February 10th will receive a ballot (by email, from OpaVote) and be eligible to vote for a State Senate District "7" candidate to receive an ECDC endorsement. Please read these instructions carefully.

Eligible voters will receive a ballot with three choices:

- a. Jesse Arreguín
- b. Jovanka Beckles
- c. No Endorsement

If we have a valid email address, you will get an email from noreply@opavote.com. This may show up as "OpaVote Voting Link" in your email. Please be sure to check your Junk or Spam folder, as your filter may block this from arriving in your Inbox. Inside the email will be a blue button with the word "Vote" in it. It will be a graphic, so you may need to allow images to be loaded in order to see the button.

PLEASE DO NOT FORWARD YOUR OPAVOTE EMAIL. This ballot is linked to your specific email account and only you should use it to vote.

After you check off the boxes, you will be asked to review your ballot. When you click on the submit button at the bottom of the ballot, you will get a pop-up screen asking to confirm your vote. If you have your pop-up blocker turned on, this confirmation screen may not show up. Please turn off your pop-up blocker before proceeding with the vote. Once you click on the second submit button, you will not be able to change your vote. Replacement ballots will not be issued if you accidentally submitted an incomplete ballot. We have no way of invalidating a ballot that was submitted, even inadvertently.

Members who are the second person in a household and that do not have an email registered with the Vice President of Membership will need to rely on a link to the OpaVote website AND a unique code. The link and the code will be sent to the email that is registered with the VP of Membership for their partner at the same address. The email address that receives the website link and code may forward this email to the intended recipient. The voting experience will be similar to the description above. Again, Greg Lyman is your resource for any issues.

- There will be a single ballot for candidates.
- This Ballot will be made available for voting on Tuesday, March 26, after 7:00 pm.
- The voting deadline will be 7:00 pm on Wednesday, March 27, 2024.
- All technical support will end at 6:00 pm on Wednesday, March 27, 2024.

Please be sure to vote by the deadline of 7:00 pm on Wednesday, March 27, 2024.

The website for OpaVote is https://www.opavote.com. All votes are anonymous. Greg will be able to see if you cast your ballot but not how you voted. This is important to assist you with your voting experience.

6. ECDC Endorsement Ballot Explained

Members in Good Standing have the option of casting a vote for the ECDC to endorse a State Senate District "7" candidate. Additionally, a "No Endorsement" option will be available. It is also possible to not select any option in the race. The Club will have an official position only if a candidate or the "No Endorsement" option is selected on at least 60% of the ballots cast.

"No Endorsement" Explained. A selection of "No Endorsement" means you want the Club to officially take a position that no candidate deserves the Club's endorsement. A "No Endorsement" vote is a very powerful statement and should not be used because you have no interest or knowledge about the candidates in a race. A "No Endorsement" vote should be cast when there is a clear reason to cast the vote. If you do not know enough about the candidates to have formed an opinion and you personally do not want your vote to influence the outcome, then simply leave all options unchecked on that race. A "No Endorsement" vote is used in the denominator to determine if a candidate reaches the 60% threshold.

In the Favorite Color race, 20 people decided not to cast a vote (left all choices blank). The denominator for determining if any color received 60% is 90. Blue received 54 of the 90 votes cast and was 'endorsed'. Although Gold received 46 votes, Gold did not get 60% of the votes cast.

In the Favorite Day of the Week race, 30 people did not like the choices and did not cast a vote. The denominator determining if any day received 60% is 80. Although Friday received the majority of the votes, neither Friday, any other individual day nor "No Endorsement" received enough votes to reach the 60% threshold. As no consensus was reached, the Club remains silent on Favorite Day of the Week.

In the Favorite Berry race, 10 people decided not to cast a vote. The denominator for determining if any berry received 60% is 100. Blueberry received all of the votes cast for a berry, however, No Endorsement received 63 of the 100 votes cast. The Club position would be published as "No Endorsement". In this case, "No Endorsement" would indicate that the Club, based on the information available, does not like the choices, despite the fact that all votes for a berry were for Blueberry.

Here is how our Endorsement would be published:

Favorites Color: Blue Endorsed

Favorite Day of the Week: No Consensus

Favorite Berry: No Endorsement

7. Organizations Nominated for Donations from ECDC

(Environmental and Climate Change; nominated by Neil Trutsui)

Importantly, 350 Contra Costa recognizes the crucial role of political action. RYSE is a Richmond, California nonprofit founded in 2008 to provide sanctuary for youth in a complex and dangerous city. RYSE never strayed from its mission, and is now a lively and bustling safe space grounded in social justice, empowering youth to love, learn, educate, heal and transform lives and communities.

RYSE offers varied programs and services. Youth may meet to explore characteristics of a healthy relationship, get homework/tutoring help, attend cooking classes, or use RYSE's more in-depth supports such as case management for those who have come in contact with the juvenile justice system.

They employ a staff committed to youth.

EdFund West Richmond Rapid Relief Fund (R3F) and Richmond Rapid Response

(Youth; nominated by Leslie Reckler)

R3F is an emergency fund that provides immediate gift card/cash assistance to families in dire need. The fund has provided our most vulnerable families with immediate financial assistance for rent, car repairs, food and other dire needs and emergencies. Phase 2 has plans to expand services to rent assistance/homeless prevention and more. I recommend contributions to "Phase 1,COVID-19 Immediate Relief." Families are struggling. Many parents are working two

jobs just to keep up with inflation, and high school students are working to the detriment of their education to meet basic family needs. (Request contribution supports WCCUSD families).

More Than One Site for a New Library

It's time to get more people talking about choices for a new El Cerrito library. What about building our new library on the current site at 6510 Stockton Avenue? And there could be other sites.

For years, city officials have been saying that the Plaza BART Transit Oriented Development is the only possible site where a new El Cerrito Library can be built. This is not true, but it has been the basis for a library planning process that focuses less on the library and more on the Transit Oriented Development. Instead of giving residents a role in important decisions about the library, like the location, the city has proceeded as if El Cerrito residents have already chosen this site. At the few public meetings held about the library so far, residents have been invited to list features they would like to see inside this pre-selected library location.

This has not been an engaging, transparent, or thorough approach. The city will ultimately need voter approval to fund any new library. Is it wise or fair to frame the issue as the Plaza BART library or no new library at all?

I would like to see a new library that is safe, energy-efficient, technologically up to date and provides welcoming spaces for programs, tutoring and community meetings. I would like it to be a community library that focuses first on residents' needs for books and information of all kinds. I don't think that Plaza BART is the best location.

Let's compare two options that do exist.

Location and Access

The Stockton Avenue site is easy to access, as shown by the high number of books being checked out from this library despite its small size. It is next door to Fairmont Elementary School, creating the opportunity for students and their families to walk over. It's next to the Ohlone Greenway, making it accessible for bicyclists, walkers and BART riders willing to take a short walk. It's in a central location that is safe and not very crowded except in the hour when school is dismissed. No new development projects are planned nearby. Street parking is available and usually easy to find. While the site has no dedicated library parking spaces, there is a parking lot behind the building where library patrons sometimes park and Friends of the Library book sales are held. The lot is owned by the school district, so its use is subject to negotiation.

The proposed Plaza BART library would occupy the ground floor of a multi-story apartment building at Fairmount Avenue and Liberty Street. The draft master plan displayed in January

shows that the Plaza BART area is going to become very congested. Developers plan to remove 750 BART rider parking spaces and build 743 apartments in six buildings. The plan calls for replacing only 150 BART rider parking spaces and providing 266 resident parking spaces in parking garages. Here also, there are no dedicated parking spaces for the library. There would be time-limited street parking on Liberty Street. The city's master plan for the area proposes narrowing Fairmount Avenue to support a goal of making the library a "destination" and a community gathering place. This site would offer easy access to people who live on the Plaza BART site or nearby and people who want to ride BART to the library. However, it would be very hard to access for El Cerrito residents and other library users who drive to the library.

Library Ownership and Management

The current library site is owned by the city.

The Plaza BART library would be in a leased space. The city would never own the land or building.

Under either option, the El Cerrito library would continue to be managed by Contra Costa County.

Size

The existing library is 6,500 square feet.

The Stockton Avenue site is appropriate for a two-story stand-alone building with an area of about 12,000 square feet. This would roughly double our current library size.

The proposed Plaza BART library would have an area of 20,000 square feet. This would more than triple our library's size.

Current Operating Cost vs. Proposed New Funding to Enhance a Bigger Library?

Currently, Contra Costa County covers the El Cerrito library's operating budget of about \$643,000/year, and makes decisions about staff, programs and materials. The city pays \$46,000/year for extra staff hours.

The parcel tax drafted by the city in fall 2023 proposed a \$22 million tax that would generate \$2.5 million per year in revenue forever. Of this amount, \$1.6 million is listed for construction and \$900,000/year is for "library hours/program enhancement."

Why would city taxpayers spend \$900,000/year for library staff hours and programs? This is 20 times the \$46,000/year the city spends now for expanded library hours, and the county

provides a turnkey operation that includes all materials and programs. Would the city be handing over extra money to the county, which would then make the decisions about this spending? Also, who would make decisions about allocating space in a new, much-larger library?

Fair Comparison?

The city states that building a Plaza BART library would "save \$10 million," although no cost estimates were ever obtained for any other site.

My Google search indicates that construction of a free-standing library would probably cost \$1,000/square foot. If that is accurate, a 12,000 square foot library would cost \$12 million.

If the city paid \$22 million for a 20,000-square-foot space, the cost would also be roughly \$1,000/square foot.

The city should provide a proposed budget and revenue assumptions for the current Stockton Avenue site as compared to the Plaza BART site.

What is the best choice? Let's give the community full information about both options and let El Cerrito voters decide.


