## 3. Minutes from the March 25th El Cerrito Democratic Club General Membership Meeting

El Cerrito Democratic Club General Membership Meeting Minutes 6:30 PM, Tuesday, April 22, 2025 (in person at Hana Gardens, 10860 San Pablo Ave, El Cerrito; and via Zoom)

#### Call to Order

President Tstutsui called the meeting to order at 6:31 p.m.

#### Review and Approve the April 2025 Meeting Agenda

On the motion of Walter and the second of Ruby, the agenda was adopted as presented. On the motion of Akacic and the second of Crowley, an amendment was added to take a position on the Richmond Street project that was presented at the March 25, 2025 General Membership meeting. The motion failed 9 Yes 11 No 1 Abstention.

The Executive Board will consider how to agendize taking a position on the Richmond St. project at their next meeting.

#### **Review and Approve the March 2025 Membership Meeting Minutes**

On the motion of Ktsanes and the second of Tsutsui, the minutes were approved as presented without the names of the motioner and second on the budget item. No one present could remember who motioned and seconded the item. The motion passed unanimously.

#### **Officer Reports:**

**President (Neil Tsutsui**) The rechartering process has begun. Champagne will help as a resource. Rechartering is separate from pre-endorsement. Membership numbers are important in the rechartering process. Lyman asks if any bylaws changes are required for rechartering. Tsutsui will check.

**Membership (Greg Lyman)** 114 members Two years ago 155 members. One year ago 141 members. It is important that your club name matches your voter registration name otherwise you will not be counted as a member.

#### Democratic Party of Contra Costa County (DPCCC) Report (Champagne Brown)

DPCCC made an endorsement in the Martinez Unified School District race. The club is holding hybrid meetings. The last meeting was in Brentwood. The next will be in El Cerrito at Hana Gardens.

**Nye** The newsletter has been revived. It should be sent out via email. DPCCC has new brochures that were given to all club presidents.

#### Update on WCCUSD, Board President & Area 5 Trustee Leslie Reckler

"How Trump will affect the School District"

WCCUSD receives about 6.5% of funds about \$30 million from federal sources. The money is predominantly for Title 1(low income) students and for special education students. Other funds support immigrant students, teacher training, career, technical education and more.

February 14, 2025, the U.S. Department of Education (DOE) mailed a "Dear Colleague" letter to all school districts telling them they had two weeks to cease all DEI programs and efforts. DEI under the DOE was, and is not clearly defined, nor are DEI programs currently illegal. The CA Department of Education (CDE) responded to DOE for districts saying that schools would not cease, as it was not clear what was illegal, there are legal ways to pass laws and a "Dear Colleague" letter is not it, and CDE would consider legal action if necessary.

DOE opened a "End DEI portal," where anyone can report a DEI-related discriminatory practice. It is not clear how districts get notified, or who investigates these submissions, or the criteria used to determine that a DEI practice is discriminatory.

Trump is moving to dismantle the Department of Education (DOE). DOE employees were laid off, and it is not clear what the plan is. Are parts returning to the states, reassigned to different federal departments? Don't know.

Schools used to be hands-off for ICE, Trump now says that schools and places of worship are fair game. This has scared families.

Early April, DOE sent another letter to school districts asking them to confirm and to sign that they had discontinued their DEI programs and practices. CDE suggests not signing it.

WCCUSD and hundreds of other districts across the nation are on a DOE-compiled DEI list. It seems the districts were chosen because they have an equity policy, have equity statements or DEI policies or practices. Again, there is no indication that these practices are illegal. It is not clear what will happen to districts that are on this list.

Transgender athletes. It is CA law that transgender athletes play on the team that corresponds to their gender identity. In CA, there were two bills that were looking to change the law in various ways, but they were both blocked. However, Maine is in a legal battle with Trump over transgender athletes, and Trump is threatening federal funding. It is hard to say what is going to happen.

There is a case that was heard today in the Supreme Court. A Maryland school district adopted an English Language curriculum that is very diverse and shows many different types of people in many different types of settings (dog gets lost at a Pride parade).. Parents complained that it violated their religious beliefs- particularly curriculum that reflects LGBTQIA+ people or settings. School district did not let kids opt out because it is the curriculum and it would be impossible for the school district to manage all of the opt-outs. Conservative justices were not convinced of the argument. The case could have far-reaching implications for all districts about curriculums, diversity in curriculums and a parent's ability to opt-out of curriculums for religious reasons.

The West Contra Costa Unified School district cannot afford to lose federal funding.

#### Program: John Gioia, Contra Costa County Supervisor, District 1:

There is uncertainty and risk to local services. There are budget hearings at the Board of Supervisors next Monday and Tuesday. The majority of health services are funded by the federal government. Out of \$7billion, \$4 billion is for the health system. There could be a substantial cutback in Medicaid funding in CA. 50% is paid by the feds and 50% is paid by the state of CA. The Feds have said California will not have its waiver renewed. 40% of households in the county have someone in the household that receives Medicaid funding. If Medicaid is reduced, there will be reduction of hours at clinics, loss of providers, higher co-pays and people losing health coverage. Less healthy county and community.

These cuts affect all communities blue and red. Red and blue counties are trying to speak with a single voice because it affects everyone.

Food Stamp program (CalFresh) is funded 50% federal and 50% state. Reductions in funding could impact food stamps.

Head Start is at risk of cuts.

A suggested strategy is to work with colleagues in swing districts to stand up to oppose these cuts. Tell stories about what this means in our communities.

Collective advocacy to prevent a budget passed with significant cuts to Medicaid. They could potentially make decisions quickly. There will be immediate impacts. State can't make that up. Locally, I can't make it up. Advocacy in swing congressional districts. There are enough

Be prepared to be flexible. Advocacy, and be prepared for litigation.

ECDC is proud to host El Cerrito's own Fire Marshall and Battalion Chief Chase Beckman. Fire Marshall Beckman will discuss defensible space requirements, zone zero, home hardening, fire hazard severity zone maps, and Measure X.

Biography: Chase Beckman has over 25 years experience in the fire service field. He began his career in 1998 as a seasonal firefighter with CAL FIRE, where he continued to work for the next 20 plus years. During his long tenure with CAL FIRE, he worked as a Firefighter, Helitack firefighter, Schedule A & B Engineer, Engine Fire Captain, Hand Crew Fire Captain, Deputy Fire Marshal, and as a Fire Captain in the Northern Region Land Use Planning Program.



Chase joined the El Cerrito Fire Department in January of 2022 as a Battalion Chief and Fire Marshal. Chase is responsible for shift coverage and associated operations, as well as all exterior hazard abatement inspection, plan review, public education, ordinance adoption and code interpretation and violation enforcement operations for the El Cerrito Kensington Fire Department. Chase is a Board member of the Diablo Fire Safe Council. He has an A.A Degree in Liberal Science and holds numerous State Fire Marshal certifications and fire line qualifications. Chase is a baseball coach in the greater East Bay area where he lives with his wife and 3 children in Martinez.
